## Directions

### From Points North:

Northern State Parkway to Exit 44 South or L.I. Expressway to Exit 53 South- Sagtikos Parkway South to Exit S3/ Pine Aire Drive Exit.

## General Information

### Ribbons

All dogs passing the test will receive an ATT ribbon.

### Collars, Leashes and Harnesses

Dogs may wear slip collars on a dead ring, buckle collars, Martingales or body harnesses.

Dogs may **NOT** wear prong collars, e-collars, head collars or harnesses that restrict movement for test.

Leashes should be 4 to 6 feet in length and made of fabric or leather.

Retractable leashes are **NOT** allowed on test grounds.

The AKC Temperament Test (ATT) is a general temperament test for all breeds and mixed breed dogs. It will assess the dog's reaction to a variety of stimuli. The test consists of six categories: Social, Auditory, Visual, Tactile, Proprioceptive and Unexpected.

Each dog needs two qualifying scores under two different judges in order to achieve an ATT title.

After earning two qualifying legs, the owner must file an application with the AKC to receive the title and certificate.

## SITE INFORMATION

### Protocols & Procedures

Due to the Covid-19 virus pandemic we have had to make some changes and add procedures to enable us to hold the test as safely as possible. We will be following the mandates set by the State of New York as well as the protocols set by the Suffolk Obedience Board. - Masks, **which fully cover your mouth and nose**, will be required while in the facility at ALL times. -Temperature checks will be performed as you enter the facility. If your temperature is normal, you will be issued a wristband that is to be worn for the day. -Social distancing of at least 6 feet is required while in the facility. -The number of persons inside the facility and in each area will be limited. There will be no spectators permitted at this time. -Only Dog testing will be allowed in the facility. -Exhibitors shall wait outside at a safe distance until test personnel indicates they may enter the facility. We will allow handlers to enter the building to use the restroom facilities. Handlers may be asked to wait outside until others have exited to ensure we have not exceeded the allowed count of persons in the facility.

-There will be **NO CRATING** of exhibitor's dogs in the building. - There will be no food or water provided. Everyone should bring their own food/water for themselves and their dogs. - Instructions shall be given at briefings and posted throughout show site. **-If you feel ill for any reason, PLEASE stay home. -Any person not cooperating or complying with the trial protocols shall be excused from the trial site and NO REFUND shall be issued. We are doing our best to ensure everyone has a safe and fun day. This is new to us all and we will be making adjustments as needed. -We appreciate your cooperation and patience and thank you in advance.**
