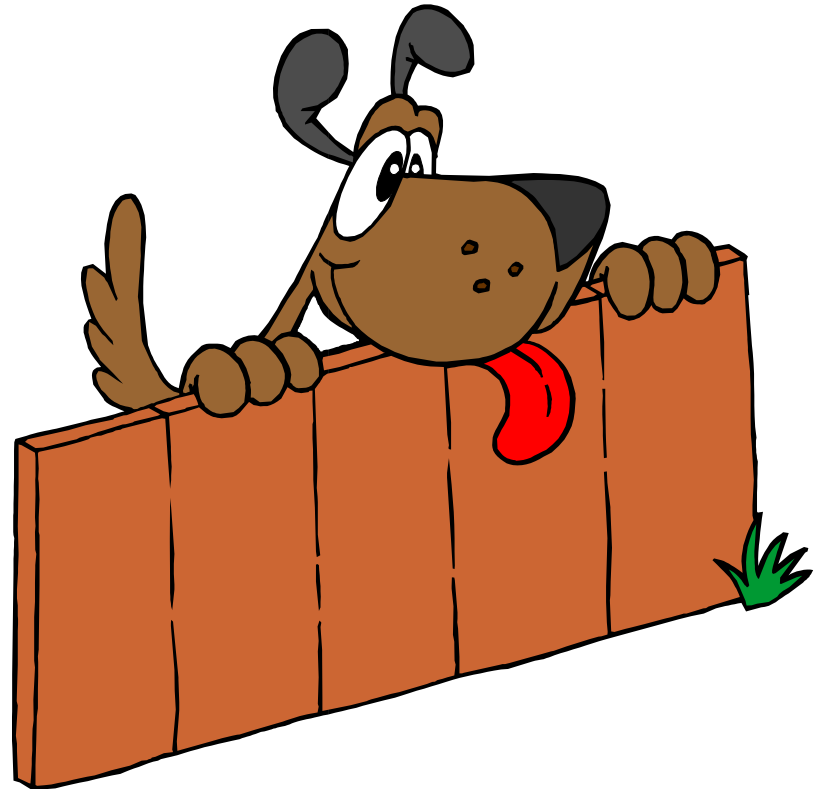

## **JUDGING SCHEDULE**

Utility judging starts at 9:00 a.m. followed by Versatility, Open, Novice and Starter Novice. Trial 2 will follow Trial 1 and a brief lunch break.

Note: We will provide snacks and a light lunch buffet. Donations gratefully accepted. Metal folding chairs are also available. Feel free to bring your own chair for comfort. **Crating in the facility is tight, but we should be able to accommodate all entered dogs. Also, parking is right outside the Building, so you can work out of your car.**



## Notice to Exhibitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of CDSP Competition Obedience rules and regulations including but not limited to the following rules regarding entry:

- ◆ This trial is open to dogs at least six months of age, including purebred and non-purebred, and to dogs with disabilities who are not in pain or discomfort.
- ◆ Bitches in season may not compete. Refunds less an administrative fee will be given for bitches in season if request is accompanied by a note from the exhibitor's veterinarian.
- ◆ Dogs exhibiting signs of aggression that threaten the safety of other dogs or humans will not be allowed on the show grounds.
- ◆ All dogs must have a CDSP registration number prior to competing.
- ◆ Dogs must be shown by a member of the owner's immediate family: mother, father, spouse, life partner, sibling, child, grandparent, or grandchild.
- ◆ Safety shall be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- ◆ The organizing committee may refuse any entry for any reason.
  
- ◆ THERE SHALL BE NO REFUND for entries withdrawn or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.
- ◆ Returned checks do not constitute a valid entry. There will be a \$35.00 service charge for returned checks. Payment of entry fees and service charges shall be made in cash or by money order within 30 days of postmark of notice of returned check where notification is received after event date. Any fees not received within 30 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible, and all awards must be returned within 10 days of notification or the dog's registration may be suspended pending restitution. Any unpaid fees or shortfalls must be paid prior to the start of the event, or entry is canceled without recourse by owner/handler.
- ◆ Credit card payments will not be accepted for these trials
- ◆ No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of the organizers.
- ◆ All dogs shall be shown in a flat buckle or snap collar, or properly fitted martingale (limited slip) collar. No choke collars, prong collars, shock collars, harnesses, martingale leads, or head collars are allowed.
- ◆ All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes. Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
- ◆ Dogs must be on leash while on show grounds and in the parking lot.
- ◆ Please pick up after your dog and yourself.

## A, B and C CLASSES

### Starter Novice A

The Starter Novice A class shall be for dogs who have not earned any other obedience title in any registry and does not have a qualifying score (Q) in Novice in any obedience registry.

### Starter Novice B

The Starter Novice B class shall be for dogs who have earned a Beginner Novice (BN) obedience title or equivalent in any registry and does not have a qualifying score (Q) in Novice in any obedience registry.

### Starter Novice C

The Starter Novice C class shall be for dogs who have earned a CDSP Starter Novice title (SN-C) in either the A or B class and does not have a qualifying score (Q) in Novice in any obedience registry. The Starter Novice order of exercises shall apply.

Once a team has earned a title in the Starter Novice A/B class, it may continue to compete in the Starter Novice C class for Advanced titles.

**NOVICE:** If, at the time you complete this entry, the dog you are entering has not earned any obedience or rally titles in any venue, including CDSP, you may enter the Novice A class. If the dog you are entering has earned any obedience or rally titles, you must enter the Novice B class. If the dog has earned a CDSP novice title and is working toward a CD-CCH please enter the Novice C class.

If, after submitting this entry, a dog you have entered in the Novice A class earns an obedience or rally title, in any venue, you must notify the Trial Secretary immediately. Please see the chart on the last page of this premium if you are unsure of your dog's jump height.

**OPEN:** If the dog you are entering has not earned an Open title in any Registry, you may enter Open A. If the dog you are entering has earned an Open title in any Registry you must enter Open B. If you have earned a CDSP Open title and are working toward a CDX-CCH, please enter the Open C class.

**UTILITY:** If the dog you are entering has not earned a CDSP Utility title, you must enter Utility A. If you have earned a CDSP Utility title and are working toward the UDX-C or OTCH-C, please enter the Utility B class. If you have earned a CDSP Utility title and are working toward a UD-CCH, please enter the Utility C class.

### Versatility A

The Versatility A class shall be for dogs who have earned the CDSP Novice obedience title (CD-C) and **not** earned any Open or Utility qualifying legs and/or titles.

### Versatility B

The Versatility B class shall be for dogs who have earned the CDSP Novice obedience title (CD-C) and earned any Open or Utility qualifying legs and/or titles.

### Versatility C

The Versatility C class shall be for dogs who have earned a CDSP Versatility title (VT-C) in either the A or B class.

## AWARDS

A qualifying ribbon will be awarded to each team who earns a score of 170 or higher. Placement rosettes will be awarded to the four top scoring teams in each class. Rosettes will also be awarded for new titles and High In Trial.
