DOGS ELIGIBLE TO ENTER

This Trial is open to all dogs over the age of 6 months that are registered with the American Kennel Club (including mixed breeds), or are a registerable breed that has obtained an AKC, ILP, PAL or MA number; except bitches in season, aggressive dogs or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Dogs that are blind or deaf shall not be eligible. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Dogs under 6 months of age are not permitted on show grounds.

NOTICE TO EXHIBITORS

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

ENTRIES & FEES: MAKE ALL CHECKS & MONEY ORDERS payable to **SOTC**. All fees are payable in US funds. **ENTRY FEE** \$30.00 for first entry of a dog, and \$15.00 for additional entry of same dog, (*Includes \$3.00 AKC Recording Fee per entry for Rally*). Mail entries and fees to SOTC, c/o Lynn Currie, 209 Tara Circle, Chesapeake, VA 23322. **ENTRIES NOT ON AN OFFICIAL AKC ENTRY FORM or photocopies of an entry form without the agreement will not be accepted. Fax, telephone and unsigned entries cannot be accepted. Entries received without fees will not be accepted. Returned checks do not constitute a valid entry. A charge of \$25 will be made for each returned check.** Entry fees shall not be returned in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competition by action of the Trial Committee. If because of riots, civil disturbances or other acts beyond the control of the club, it is impossible to open or complete the trial, no refund will be made. **Errors** – Exhibitors are responsible for filling out complete, accurate entries and no entry fee will be refunded in the event of such errors or the cancellation of entries after the trial has closed.

No hand delivery of entries.

Acknowledgement of entries will be made as soon as the trial closes or when limits are reached.

No Bitches in season allowed. Refunds less \$10.00 administrative fee will be made for bitches that come into season after the closing date of the trial. A written request must be made accompanied by a letter from a veterinarian within 24 hours of trial completion.

Judges are not required to wait for dogs. Exhibitors are solely responsible for getting their dogs to the ring on time.

ALL DOGS NEED TO BE CRATED IF THEY ARE BROUGHT INTO THE BUILDING PRIOR TO THEIR RUNS. FOR THE SAFETY OF ALL DOGS AND EXHIBITORS YOU EITHER MUST WORK OUT OF YOUR CAR OR A CRATE. YOU ARE NOT ALLOWED TO SIT WITH YOUR DOG LOOSE AT THE ENTRANCE TO THE TRAINING FACILITY. DOGS NEED THE SPACE TO PASS BACK AND FORTH TO THE RING AREA WITHOUT HAVING OTHER DOGS IN THEIR FACE.

SITE INFORMATION

- **There will be NO set up on Friday Night.** The Training Center will be open at 7:00 AM on Saturday the 9th.
- Please park in the designated parking areas next to the building and in the adjacent parking lots.
- There is a designated “potty” area. Please clean up after your dog and place waste in the receptacles provided by the Club. **DO NOT** use any dumpster or allow dogs to urinate on the buildings.
- Crating Space is limited, but should accommodate all entered dogs. Please do not bring dogs that are not competing into the building. **NO EX-PENS.**
- Snacks and beverages may be available for donation. However, there are numerous food venders within walking distance of the facility.

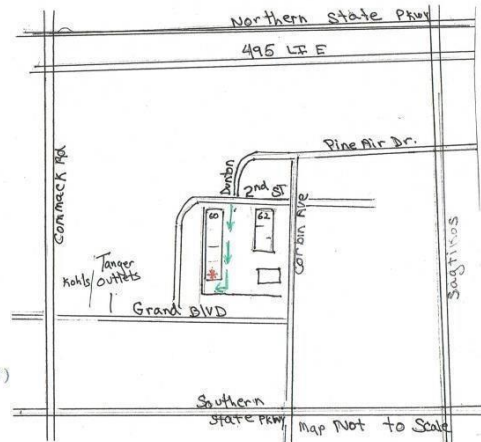
To Grand Blvd.- Head east -follow to end -
